### Message from the **EurOMA President**

This is my last message for the EurOMA Newsletter as President of the Association because I will hand over to my successor at the annual conference at INSEAD in Fontainebleau.

At the time of writing I am attending the World Conference on POM in Cancun, Mexico, where EurOMA and JSPM (the Japanese Society for Production Management) have joined with POMS (the Production and Operations Management Society) to welcome delegates to the second such event, the first having been hosted in Sevilla in 2000.

It has certainly proved to be very successful, with more than 500 participants attending, among which around 135 are from Europe. The World Conference now looks set to be a regular event in the calendar of the three associations represented here.

The day I am writing this message is 1st May, which is also a very special day for the European Union (EU) as it is enlarged by the entry of ten new countries.

I should stress that EurOMA has never considered itself to be only the EU Operations Management Association and its scope in Europe has always extended beyond the fifteen EU states.

Indeed a large number of members come from the rest of the world, including Australasia, South America the USA etc.

However, I strongly believe we will now see much greater participation in our activities from the new EU countries, especially since our annual conference next year will be organised in Budapest, the first to be held outside the "old"

The EurOMA Board will be witnessing a lot of changes in the coming months. Our Executive Secretary, Jeanny Kieffer, has recently retired and we wish her well.

We welcome Jeanny's replacement, Audrey O'Connor, who I am sure will soon feel at home among the European OM community.

This year four members of the Board are also standing down according to the governance arrangements, including myself.

I have decided not to stand for re-election because every organisation needs to be reinvigorated.

I will be sad to leave after serving on the Board since the formation of EurOMA and for ten years previously on the Board of the former OMA-UK. However I look forward to seeing the Board injected with fresh energy and ideas.

# Report on Questionnaire Results

#### Dear EurOMA members,

First of all, thank you for the time you devoted to fill in the questionnaire in December 2003. Hereby you can read some of the results.

There were 96 responses for the questionnaire, which is a 25% response rate. The first question asked about the preferences for the physical form of the papers. The four options and the frequency of answers (absolute numbers) were the following:

- I prefer paper format as up till now (33)
- I prefer disk format (16)
- I prefer mixed: the volume with my own paper in paper format, and all the other volumes in disk format (11)
- I prefer extended abstracts in paper format, full papers in disk format (36)

In order to keep the high professional level of the conference the board insisted on having some kind of paper format. Finally, the board decided to continue the paper format with a page limit (10 pages). However, as approximately 65% of people preferred disk with or without paper

format, thus the participants will also get disks, which is included in the registration fee.

There was a very close result concerning the length of the conference. 53% of the participants wanted to stay with the traditional format, while 47% chose the option to extend. As a consequence, the number of conference days will not change.

A lot of people offered help in the preparation of the conference. Half of them are ready to chair a session and/or review abstracts, and one third to take a position in the academic advisory board. We will take these offers into account in the right time, thank you.

I hope you found this feedback useful and you feel that you did not waste your time when you filled in the questionnaire.

### 2nd World Conference Production & Operations Management

Europe was well represented in the Second World Conference co-jointly organized by the Production and Operations Management Society (POMS), the Japan Society for Production Management (JSPM) and EurOMA. This event held in Cancun, Mexico, from 30th April – 3<sup>rd</sup> May, was attended by over 500 participants.

The conference included 399 contributed and invited papers, organized around 5 thematic clusters (Operations and Logistics, Service and Quality, Environment and International, Strategy and Design, and POM Pedagogy) and twenty-one tracks. The papers' authors, 513 in total (36% of them Europeans), came from 37 different countries. Spanish authors were offered the possibility of presenting in Spanish in specially selected tracks. Spain (53) and UK (47) were the best-represented European countries.

Prof. David Bennett, President of EurOMA, and many other members enjoyed the relaxed atmosphere of Cancun Hilton hotel to exchange their views on the new research results presented at the conference.

The first keynote speaker, Bart J. Groot from The Dow Chemical Company, explained the challenges experienced in the project to bring three former East German chemical sites to world class and global competitiveness in five years after their acquisition in 1995. The keynote speaker of the third day, Nampachi Hayashi of Toyota Motor Corporation described the evolution of the Toyota Production System from its origins until present days and questioned the sustainability of the competitive advantages of plants moved to China and other low-cost labour countries.

The academic setting was complemented by a wide offering of site tours on the days immediately before and after the conference. Most of the participants enjoyed the opportunity to visit the Mayan sites of Tulum and Chichen Itza, within a driving distance of Cancun.

The First World Conference was organized in Seville, Spain, in 2000 under the leadership of Jose A. Dominguez Machuca (member of the EurOMA board) and his team at the University of Seville. The great success of that event encouraged the organizations involved to extend it into a series, with a cadence of 4 years. This Cancun conference has been the second one and preparations are already under way to the Third World Conference in Production and Operations Management to be held in Japan in 2008.

#### **Best Practice Showcase**
